Cadei in Harris v. McLaughlin Case No. 34-2015-00176996.

The amount of "reactionary" poorly written legislation being proposed in anticipation of the Supreme Court decision is mind boggling. Most of this legislation is not taking in consideration the consequences it may have on children and families, such as when Virginia abolished their "Domestic Partnership" law. Many children in those families lost health care coverage because now their parents became "just roommates."
